The garden to the front has an area of lawn with mature planted borders. The rear garden is also mainly lawn with mature planted border & patio area.

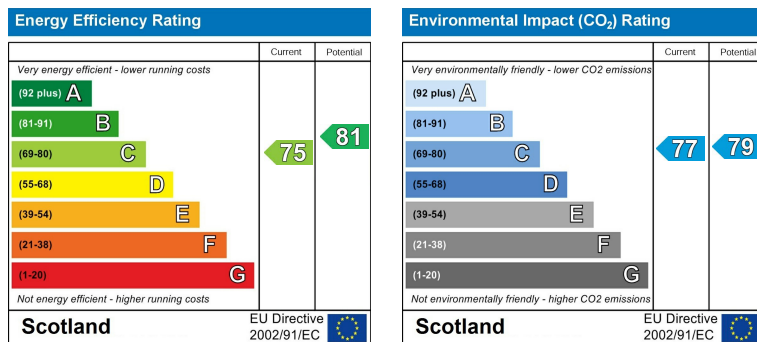
